WISDOMTREE PRIME E-SIGN CONSENT

WisdomTree Digital Movement, Inc., and its affiliates and third-party service providers (collectively, “**WisdomTree Digital**”, “**we**” “**us**” or “**our**”) may need to provide you with certain communications, notices, agreements, policies, payment authorizations, transaction receipts, transaction confirmations, account statements, tax documents, or disclosures in writing (collectively “**Communications**”) regarding the services we offer through WisdomTree Prime™ (“**App**”). By checking the box and accepting this consent, you consent to receive and view Communications from WisdomTree Digital relating to your account with WisdomTree Digital electronically, rather than in paper form, and to the use of electronic signatures in connection with our relationship with you.

Delivery of Communications and Use of Electronic Signatures

In accordance with the terms of this consent, WisdomTree Digital may provide all Communications electronically by the following means: 1) email; 2) text messages to your mobile phone; 3) notifications from our App. You agree to maintain on file with us true, accurate and complete information in your Account profile, including your email address and contact information. Your consent to receive Communications electronically shall last until you withdraw your consent or otherwise terminate your Account with us.

If you choose not to agree to this consent, you will be restricted from using our App.

Withdrawal of Consent to Receive Electronic Communications

You may withdraw your consent to receive electronic Communications at any time, by clicking the “Contact Us” button within the App or submitting your request in writing to: Legal Department, WisdomTree Digital, 250 West 34th Street, 3rd Floor, New York, NY 10119. Please note that withdrawal of your consent to receive electronic Communications will result in termination of your account and access to our App. Accounts with WisdomTree Digital are only intended for individuals who are willing and able to receive Communications exclusively through electronic means. Any withdrawal of your consent will be effective after a reasonable period of time for processing your request, and WisdomTree Digital will confirm your request to withdraw consent and its effective date in writing (either electronically or in paper form).

Hardware and Software Requirements

In order to access, view and retain electronic Communications that are made available to you, you must have the following:

- i. A mobile device that is either: 1) an Apple iPhone running version 12.0 or higher; or 2) an Android phone running Android version 6.0 or higher.

- ii. Access to an active email account with an email service provider.

WisdomTree Digital will not send you a paper copy of any Communications, however, we reserve the right, but assume no obligation or responsibility, to provide a paper copy of any Communications that you have authorized us to provide in lieu of providing the same electronically.

Federal Law

You acknowledge and agree that your consent to electronic Communications is being provided in connection with a transaction affecting interstate commerce that is subject to federal Electronic Signatures in Global and National Commerce Act (the “Act”), and that you and we both intend that the Act apply to the fullest extent permitted by applicable law to validate our ability to conduct business with you by electronic means.

Termination

WisdomTree Digital reserves the right, at our sole discretion, to discontinue the provision of your electronic Communications, or to terminate or change the terms and conditions on which we provide electronic Communications. We will provide you with notice of any such termination or change as required by applicable law.
