WisdomTree Short GBP Long EUR 3x Daily

Investment Objective

WisdomTree Short GBP Long EUR 3x Daily is a fully collateralised, UCITS eligible Exchange Traded Product (ETP) designed to provide investors with a leveraged short exposure to GBP relative to EUR. The ETP tracks the MSFXSM Triple Short British Pound/Euro Total Return Index (MSCEEGUS), providing a total return comprised of 3 times the daily performance of FX forward contracts being Short GBP relative to EUR, plus the interest revenue adjusted to reflect fees and costs associated with the product. For example, if GBP rises by 1% relative to EUR over a day, then the ETP will fall by 3%, excluding fees. However if GBP falls by 1% relative to EUR over a day, then the ETP will rise by 3%, excluding fees.

Index Description

The Index provides a 3x leveraged 'short' exposure to: (i) GBP relative to EUR. For example, if GBP were to rise in value relative to EUR, the Index (tracked by the ETP) would decrease in value by three times the same amount. Conversely if GBP were to decrease in value relative to EUR, the Index would increase in value by three times the same amount; and (ii) an interest rate differential reflecting the difference between the GBP and the EUR exchange rates.

The Index is a total return index, which means that it also provides a collateral yield.

Glossary

Authorised participant: Banks or other financial institutions that act as intermediaries between issuers of securities and other investors or intermediaries. Authorised participants subscribe for and redeem securities directly with the Issuer and buy and sell those securities to investors intermediaries either directly or via stock exchanges.

Collateral held: Cash or other transferable securities which are held independently to reduce the Issuer's credit risk in respect of any single counterparty. For example, if the Index (tracked by the ETP) increases, the amount owed to the Issuer by the swap counterparty increases and therefore additional collateral is transferred by the swap counterparty to reduce the increased risk to the ETP of that counterparty.

Exposure: An ETC has exposure to an index or commodity if its value is directly affected by movements in the price of that index commodity. Exposure to an index or commodity can be achieved in various different ways. This ETC aims to provide exposure to the Index using swaps.

Swap counterparty: Typically a large bank or financial institution with whom the Issuer enters into swaps
