

# WisdomTree Battery Metals

## Investment Objective

WisdomTree Battery Metals is a fully collateralised, UCITS eligible Exchange Traded Commodity (ETC) designed to provide investors with a total return exposure to a basket of Battery Metals futures contracts. The ETC provides a total return comprised of the daily performance of the WisdomTree Battery Metals Commodity Index (WTBMCTR), adjusted to reflect fees and costs associated with the product. For example, if the WisdomTree Battery Metals Commodity Index rises by 1% over a day, then the ETC will rise by 1%, excluding fees. However if the WisdomTree Battery Metals Commodity Index falls by 1% over a day, then the ETC will fall by 1%, excluding fees.

## **Index Description**

The Index is designed to track the performance of a diversified basket of commodities that are associated with battery themes, which include, but are not limited to Electric Vehicles, Charging, and Energy Storage.

The Index was developed by WisdomTree Investments, Inc. ("WTI"), in collaboration with third party specialists in the battery space. The selection and weighting of index components is based on an Intensity Rating, created in collaboration with third parties, which measures the exposure and growth metrics for each commodity within the usage of battery and energy storage technologies.

The maximum weight of each commodity is capped at 40% at the rebalance. The Index is reconstituted on an annual basis in January and with a quarterly review process. Excess and Total Return versions of the Index are calculated and published.

## Glossary

**Authorised participant:** Banks or other financial institutions that act as intermediaries between issuers of securities and other investors or intermediaries. Authorised participants subscribe for and redeem securities directly with the Issuer and buy and sell those securities to investors intermediaries either directly or via stock exchanges.

**Collateral held:** Cash or other transferable securities which are held independently to reduce the Issuer's credit risk in respect of any single counterparty. For example, if the Index (tracked by the ETP) increases, the amount owed to the Issuer by the swap counterparty increases and therefore additional collateral is transferred by the swap counterparty to reduce the increased risk to the ETP of that counterparty.

**Exposure:** An ETC has exposure to an index or commodity if its value is directly affected by movements in the price of that index commodity. Exposure to an index or commodity can be achieved in various different ways. This ETC aims to provide exposure to the Index using swaps.

Market Makers: Banks or other financial institutions that act as intermediaries between buyers and sellers of securities. They buy and sell securities to investors intermediaries either directly or via stock exchanges.

**Swap counterparty:** Typically a large bank or financial institution with whom the Issuer enters into swaps
