Objectives

WisdomTree Livestock is a fully collateralised, UCITS eligible Exchange Traded Commodity (ETC) designed to provide investors with a total return exposure to a basket of Livestock futures contracts. The ETC aims to replicate the Bloomberg Commodity Livestock Subindex 4W Total Return Index (BCOMLI4T) by tracking the Bloomberg Livestock Sub Excess Return Index and providing the interest revenue adjusted to reflect fees and costs associated with the product. For example, if the Bloomberg Commodity Livestock Subindex 4W Total Return Index rises by 1% over a day, then the ETC will rise by 1%, excluding fees. However if the Bloomberg Commodity Livestock Subindex 4W Total Return Index falls by 1% over a day, then the ETC will fall by 1%, excluding fees.

You may trade this product on various stock exchanges at your own discretion. Price changes in the futures contracts referenced in the Benchmark will not necessarily result in correlated changes in the level of the Benchmark or of the Product. This may be due to a number of factors including the effect of "rolling" of futures contracts.

Term

This product does not have a fixed term. The term will depend on how long you choose to hold the product. The Issuer is entitled to terminate this product unilaterally.



What are the risks and what could I get in return?



The risk indicator assumes you keep the product for 3 years. The actual risk can be significantly higher if you cash in at an early or later stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 4 out of 7, which is a medium risk class.

The unfavourable scenario for where you exit after the recommended holding period occurred to the WisdomTree Livestock between 19/05/2017 and 13/04/2020. The moderate scenario for where you exit after the recommended holding period occurred to the WisdomTree Livestock between 16/03/2017 and 07/02/2020. The favourable scenario for where you exit after the recommended holding period occurred to the WisdomTree Livestock between 13/04/2020 and 07/03/2023. Where the period of time between the dates is less than the recommended holding period the performance has been extrapolated by linear transformation to the recommended holding period.

What happens if WisdomTree Commodity Securities Limited is unable to pay out?

What are the costs?
