# What is this product?

#### **Objectives**

WisdomTree Grains is a fully collateralised, UCITS eligible Exchange Traded Commodity (ETC) designed to provide investors with a total return exposure to a basket of Grains futures contracts. The ETC aims to replicate the Bloomberg Commodity Grains Subindex 4W Total Return Index (BCOMGR4T) by tracking the Bloomberg Grains Sub Excess Return Index and providing the interest revenue adjusted to reflect fees and costs associated with the product. For example, if the Bloomberg Commodity Grains Subindex 4W Total Return Index rises by 1% over a day, then the ETC will rise by 1%, excluding fees. However if the Bloomberg Commodity Grains Subindex 4W Total Return Index falls by 1% over a day, then the ETC will fall by 1%, excluding fees.

You may trade this product on various stock exchanges at your own discretion. Price changes in the futures contracts referenced in the Benchmark will not necessarily result in correlated changes in the level of the Benchmark or of the Product. This may be due to a number of factors including the effect of "rolling" of futures contracts.

#### Term

This product does not have a fixed term. The term will depend on how long you choose to hold the product. The Issuer is entitled to terminate this product unilaterally.



## What are the risks and what could I get in return?



The risk indicator assumes you keep the product for 3 years. The actual risk can be significantly higher if you cash in at an early or later stage and you may get back less.

We have classified this product as 4 out of 7, which is a medium risk class.

The unfavourable scenario for where you exit after the recommended holding period occurred to the WisdomTree Grains between 21/06/2023 and 28/06/2024. The favourable scenario for where you exit after the recommended holding period occurred to the WisdomTree Grains between 28/07/2020 and 21/06/2023. Where the period of time between the dates is less than the recommended holding period the performance has been extrapolated by linear transformation to the recommended holding period.
