Objectives

WisdomTree Gold 1x Daily Short is a fully collateralised Exchange Traded Commodity (ETC) designed to provide investors with a short exposure to Gold . The ETC provides a total return comprised of -1 times the daily performance of the Bloomberg Gold Sub Excess Return Index (BCOMGC), plus the interest revenue adjusted to reflect fees and costs associated with the product. For example, if the Bloomberg Gold Sub Excess Return Index rises by 1% over a day, then the ETC will fall by 1%, excluding fees. However if the Bloomberg Gold Sub Excess Return Index rises by 1%, excluding fees.

You may trade this product on various stock exchanges at your own discretion. Price changes in the futures contracts referenced in the Benchmark will not necessarily result in correlated changes in the level of the Benchmark or of the Product. This may be due to a number of factors including the effect of "rolling" of futures contracts.

The risk indicator assumes you keep the product for 1 day. The actual risk can be significantly higher if you cash in at an early or later stage and you may get back less.

We have classified this product as 7 out of 7, which is the highest risk class.
