What is this product?

Type

Jersey law governed, uncertificated, registered, collateralised debt security.

Objectives

WisdomTree Broad Commodities 1x Daily Short is a fully collateralised Exchange Traded Commodity (ETC) designed to provide investors with a short exposure to Broad Commodities . The ETC provides a total return comprised of -1 times the daily performance of the Bloomberg Commodity Excess Return Index (BCOM), plus the interest revenue adjusted to reflect fees and costs associated with the product. For example, if the Bloomberg Commodity Excess Return Index rises by 1% over a day, then the ETC will fall by 1%, excluding fees. However if the Bloomberg Commodity Excess Return Index rises by 1% over a day, then the ETC will rise by 1%, excluding fees.

You may trade this product on various stock exchanges at your own discretion. Price changes in the futures contracts referenced in the Benchmark will not necessarily result in correlated changes in the level of the Benchmark or of the Product. This may be due to a number of factors including the effect of "rolling" of futures contracts.

For periods of longer than one day, the return of the product is not the same as the return of the Index multiplied by a factor of -1 (the "Leverage Factor").
