What is this product?

Type

Jersey law governed, uncertificated, registered, collateralised debt security.

Objectives

WisdomTree Brent Crude Oil is a fully collateralised, UCITS eligible Exchange Traded Commodity (ETC) designed to provide investors with a total return exposure to Brent Crude Oil futures contracts. The ETC aims to replicate the Bloomberg Commodity Brent Crude Subindex 4W Total Return Index (BCOMCO4T) by tracking the Bloomberg Brent Crude Sub Excess Return Index and providing the interest revenue adjusted to reflect fees and costs associated with the product. For example, if the Bloomberg Commodity Brent Crude Subindex 4W Total Return Index rises by 1% over a day, then the ETC will rise by 1%, excluding fees. However if the Bloomberg Commodity Brent Crude Subindex 4W Total Return Index falls by 1% over a day, then the ETC will fall by 1%, excluding fees.

You may trade this product on various stock exchanges at your own discretion. Price changes in the futures contracts referenced in the Benchmark will not necessarily result in correlated changes in the level of the Benchmark or of the Product. The unfavourable scenario for where you exit after the recommended holding period occurred to the WisdomTree Brent Crude Oil between 10/05/2019 and 28/04/2020. The moderate scenario for where you exit after the recommended holding period occurred to the WisdomTree Brent Crude Oil between 05/12/2023 and 21/11/2024. The favourable scenario for where you exit after the recommended holding period occurred to the WisdomTree Brent Crude Oil between 28/04/2020 and 15/04/2021. Where the period of time between the dates is less than the recommended holding period the performance has been extrapolated by linear transformation to the recommended holding period.
