What is this product?

Type

Jersey law governed, uncertificated, registered, collateralised debt security.

Objectives

WisdomTree Carbon is a fully collateralised, UCITS eligible Exchange Traded Commodity (ETC) designed to provide investors with a total return exposure to Carbon futures contracts. The ETC aims to replicate the Solactive Carbon Emission Allowances Rolling Futures Total Return Index (SOLCARBT) by tracking the Solactive Carbon Emission Allowances Rolling Futures Excess Return Index and providing the interest revenue adjusted to reflect fees and costs associated with the product. For example, if the Solactive Carbon Emission Allowances Rolling Futures Total Return Index rises by 1% over a day, then the ETC will rise by 1%, excluding fees. However if the Solactive Carbon Emission Allowances Rolling Futures Total Return Index falls by 1% over a day, then the ETC will fall by 1%, excluding fees. You may trade this product on various stock exchanges at your own discretion. Price changes in the futures contracts referenced in the Benchmark will not necessarily result in correlated changes in the level of the Benchmark or of the Product. This may be due to a number of factors including the effect of "rolling" of futures contracts.

Intended Retail Investor

The unfavourable scenario for where you exit after the recommended holding period occurred to the Solactive Carbon Emission Allowances Rolling Futures Total Return Index between 17/09/2015 and 05/09/2016. The moderate scenario for where you exit after the recommended holding period occurred to the Solactive Carbon Emission Allowances Rolling Futures Total Return Index between 16/08/2016 and 03/08/2017. The favourable scenario for where you exit after the recommended holding period occurred to the Solactive Carbon Emission Allowances Rolling Futures Total Return Index between 21/09/2017 and 10/09/2018. Where the period of time between the dates is less than the recommended holding period the performance has been extrapolated by linear transformation to the recommended holding period.

What are the costs?
