#### **Objectives**

WisdomTree Wheat 3x Daily Leveraged is a fully collateralised Exchange Traded Commodity (ETC) designed to provide investors with a leveraged exposure to Wheat . The ETC provides a total return comprised of 3 times the daily performance of the Bloomberg Wheat Sub Excess Return Index (BCOMWH), plus the interest revenue adjusted to reflect fees and costs associated with the product. For example, if the Bloomberg Wheat Sub Excess Return Index rises by 1% over a day, then the ETC will rise by 3%, excluding fees. However if the Bloomberg Wheat Sub Excess Return Index falls by 1% over a day, then the ETC will rise by 3%,

You may trade this product on various stock exchanges at your own discretion. Price changes in the futures contracts referenced in the Benchmark will not necessarily result in correlated changes in the level of the Benchmark or of the Product.
