Objectives

WisdomTree Heating Oil is a fully collateralised, UCITS eligible Exchange Traded Commodity (ETC) designed to provide investors with a total return exposure to Heating Oil futures contracts. The ETC aims to replicate the Bloomberg Commodity Heating Oil Subindex 4W Total Return Index (BCOMHO4T) by tracking the Bloomberg Heating Oil Sub Excess Return Index and providing the interest revenue adjusted to reflect fees and costs associated with the product. For example, if the Bloomberg Commodity Heating Oil Subindex 4W Total Return Index 4W Total Return Index is by 1% over a day, then the ETC will rise by 1%, excluding fees. However if the Bloomberg Commodity Heating Oil Subindex 4W Total Return Index falls by 1% over a day, then the ETC will fall by 1%, excluding fees.

You may trade this product on various stock exchanges at your own discretion. What are the risks and what could I get in return?
