Objectives

WisdomTree Coffee 2x Daily Leveraged is a fully collateralised Exchange Traded Commodity (ETC) designed to provide investors with a leveraged exposure to Coffee . The ETC provides a total return comprised of 2 times the daily performance of the Bloomberg Coffee Sub Excess Return Index (BCOMKC), plus the interest revenue adjusted to reflect fees and costs associated with the product. For example, if the Bloomberg Coffee Sub Excess Return Index rises by 1% over a day, then the ETC will rise by 2%, excluding fees. However if the Bloomberg Coffee Sub Excess Return Index rises by 1% over a day, then the ETC will rise by 2%,

You may trade this product on various stock exchanges at your own discretion. Price changes in the futures contracts referenced in the Benchmark will not necessarily result in correlated changes in the level of the Benchmark or of the Product. For periods of longer than one day, the return of the product is not the same as the return of the Index multiplied by a factor of 2 (the "Leverage Factor"). We have classified this product as 7 out of 7, which is the highest risk class.
