Objectives

WisdomTree Copper 2x Daily Leveraged is a fully collateralised Exchange Traded Commodity (ETC) designed to provide investors with a leveraged exposure to Copper . The ETC provides a total return comprised of 2 times the daily performance of the Bloomberg Copper Sub Excess Return Index (BCOMHG), plus the interest revenue adjusted to reflect fees and costs associated with the product. For example, if the Bloomberg Copper Sub Excess Return Index rises by 1% over a day, then the ETC will rise by 2%, excluding fees. However if the Bloomberg Copper Sub Excess Return Index fees.

You may trade this product on various stock exchanges at your own discretion. Price changes in the futures contracts referenced in the Benchmark will not necessarily result in correlated changes in the level of the Benchmark or of the Product. This may be due to a number of factors including the effect of "rolling" of futures contracts.

For periods of longer than one day, the return of the product is not the same as the return of the Index multiplied by a factor of 2 (the "Leverage Factor"). What are the risks and what could I get in return?



The risk indicator assumes you keep the product for 1 day. The actual risk can be significantly higher if you cash in at an early or later stage and you may get back less.

We have classified this product as 7 out of 7, which is the highest risk class.

This rates the potential losses from future performance at a very high level.
