Objectives

WisdomTree Natural Gas 2x Daily Leveraged is a fully collateralised Exchange Traded Commodity (ETC) designed to provide investors with a leveraged exposure to Natural Gas (Henry Hub). The ETC provides a total return comprised of 2 times the daily performance of the Bloomberg Natural Gas SL Excess Return Index (BNGSLER), plus the interest revenue adjusted to reflect fees and costs associated with the product. For example, if the Bloomberg Natural Gas SL Excess Return Index rises by 1% over a day, then the ETC will rise by 2%, excluding fees. We have classified this product as 7 out of 7, which is the highest risk class.
