# What is this product?

## Туре

#### **Objectives**

WisdomTree Corn is a fully collateralised, UCITS eligible Exchange Traded Commodity (ETC) designed to provide investors with a total return exposure to Corn futures contracts. The ETC aims to replicate the Bloomberg Commodity Corn Subindex 4W Total Return Index (BCOMCN4T) by tracking the Bloomberg Corn Sub Excess Return Index and providing the interest revenue adjusted to reflect fees and costs associated with the product. For example, if the Bloomberg Commodity Corn Subindex 4W Total Return Index rises by 1% over a day, then the ETC will rise by 1%, excluding fees. However if the Bloomberg Commodity Corn Subindex 4W Total Return Index falls by 1% over a day, then the ETC will fall by 1%, excluding fees.

You may trade this product on various stock exchanges at your own discretion. Price changes in the futures contracts referenced in the Benchmark will not necessarily result in correlated changes in the level of the Benchmark or of the Product. This may be due to a number of factors including the effect of "rolling" of futures contracts.

This product does not have a fixed term. The term will depend on how long you choose to hold the product. The Issuer is entitled to terminate this product unilaterally.



# What are the risks and what could I get in return?



The risk indicator assumes you keep the product for 1 year. The actual risk can be significantly higher if you cash in at an early or later stage and you may get back less.

What could affect my return positively?

What could affect my return negatively?

+ A decrease in the level of the Bloomberg Commodity Corn Subindex 4W Total Return.
