# What is this product?

#### **Objectives**

WisdomTree Lean Hogs is a fully collateralised, UCITS eligible Exchange Traded Commodity (ETC) designed to provide investors with a total return exposure to Lean Hogs futures contracts. The ETC aims to replicate the Bloomberg Commodity Lean Hogs Subindex 4W Total Return Index (BCOMLH4T) by tracking the Bloomberg Lean Hogs Sub Excess Return Index and providing the interest revenue adjusted to reflect fees and costs associated with the product. For example, if the Bloomberg Commodity Lean Hogs Subindex 4W Total Return Index rises by 1% over a day, then the ETC will rise by 1%, excluding fees. However if the Bloomberg Commodity Lean Hogs Subindex 4W Total Return Index falls by 1% over a day, then the ETC will fees.

You may trade this product on various stock exchanges at your own discretion. Price changes in the futures contracts referenced in the Benchmark will not necessarily result in correlated changes in the level of the Benchmark or of the Product. # What are the risks and what could I get in return?
