What is this product?

Objectives

WisdomTree Short CHF Long EUR is a fully collateralised, UCITS eligible Exchange Traded Product (ETP) designed to provide investors with an exposure to CHF relative to EUR. The ETP tracks the MSFXSM Short Swiss Franc/Euro Total Return Index (MSCEEHS), providing a total return comprised of the daily performance of FX forward contracts being Short CHF relative to EUR, plus the interest revenue adjusted to reflect fees and costs associated with the product. For example, if CHF rises by 1% relative to EUR over a day, then the ETP will fall by 1%, excluding fees. However if CHF falls by 1% relative to EUR over a day, then the ETP will rise by 1%, excluding fees.

You may trade this product on various stock exchanges at your own discretion. Price changes in the forward contracts referenced in the Benchmark will not necessarily result in correlated changes in the level of the Benchmark or of the Product. This may be due to a number of factors including the effect of "rolling" of forward contracts.

The unfavourable scenario for where you exit after the recommended holding period occurred to the WisdomTree Short CHF Long EUR between 11/10/2021 and 28/09/2022. The moderate scenario for where you exit after the recommended holding period occurred to the WisdomTree Short CHF Long EUR between 25/03/2016 and 14/03/2017. The favourable scenario for where you exit after the recommended holding period occurred to the WisdomTree Short CHF Long EUR between 26/01/2017 and 15/01/2018. Where the period of time between the dates is less than the recommended holding period the performance has been extrapolated by linear transformation to the recommended holding period.

What happens if WisdomTree Foreign Exchange Limited is unable to pay out?
