Objectives

WisdomTree Long NOK Short EUR is a fully collateralised, UCITS eligible Exchange Traded Product (ETP) designed to provide investors with an exposure to NOK relative to EUR. The ETP tracks the MSFXSM Long Norwegian Krone/Euro Total Return Index (MSCEENL), providing a total return comprised of the daily performance of FX forward contracts being Long NOK relative to EUR, plus the interest revenue adjusted to reflect fees and costs associated with the product. For example, if NOK rises by 1% relative to EUR over a day, then the ETP will rise by 1%, excluding fees. However if NOK falls by 1% relative to EUR over a day, then the ETP will fall by 1%, excluding fees. You may trade this product on various stock exchanges at your own discretion. Price changes in the forward contracts referenced in the Benchmark will not necessarily

The unfavourable scenario for where you exit after the recommended holding period occurred to the WisdomTree Long NOK Short EUR between 03/04/2019 and 20/03/2020. The moderate scenario for where you exit after the recommended holding period occurred to the WisdomTree Long NOK Short EUR between 13/07/2018 and 02/07/2019. The favourable scenario for where you exit after the recommended holding period occurred to the WisdomTree Long NOK Short EUR between 20/03/2020 and 09/03/2021.
