# What is this product?

#### **Objectives**

WisdomTree Short GBP Long EUR is a fully collateralised, UCITS eligible Exchange Traded Product (ETP) designed to provide investors with an exposure to GBP relative to EUR. The ETP tracks the MSFXSM Short British Pound/Euro Total Return Index (MSCEEGS), providing a total return comprised of the daily performance of FX forward contracts being Short GBP relative to EUR, plus the interest revenue adjusted to reflect fees and costs associated with the product. For example, if GBP rises by 1%, relative to EUR over a day, then the ETP will fall by 1%, excluding fees. However if GBP falls by 1% relative to EUR over a day, then the ETP will rise by 1%, excluding fees. You may trade this product on various stock exchanges at your own discretion. Price changes in the forward contracts referenced in the Benchmark will not necessarily

result in correlated changes in the level of the Benchmark or of the Product. This may be due to a number of factors including the effect of "rolling" of forward contracts.

The unfavourable scenario for where you exit after the recommended holding period occurred to the WisdomTree Short GBP Long EUR between 23/03/2020 and 10/03/2021. The moderate scenario for where you exit after the recommended holding period occurred to the WisdomTree Short GBP Long EUR between 28/02/2023 and 15/02/2024. The favourable scenario for where you exit after the recommended holding period occurred to the WisdomTree Short GBP Long EUR between 16/11/2015 and 02/11/2016.
