What is this product?

Type

Jersey law governed, uncertificated, registered, collateralised debt security.

Objectives

WisdomTree Short AUD Long EUR is a fully collateralised, UCITS eligible Exchange Traded Product (ETP) designed to provide investors with an exposure to AUD relative to EUR. The ETP tracks the MSFXSM Short Australian Dollar/Euro Total Return Index (MSCEEAS), providing a total return comprised of the daily performance of FX forward contracts being Short AUD relative to EUR, plus the interest revenue adjusted to reflect fees and costs associated with the product. For example, if AUD rises by 1% relative to EUR over a day, then the ETP will fall by 1%, excluding fees. However if AUD falls by 1% relative to EUR over a day, then the ETP will rise by 1%, excluding fees.

You may trade this product on various stock exchanges at your own discretion. Price changes in the forward contracts referenced in the Benchmark will not necessarily result in correlated changes in the level of the Benchmark or of the Product. This may be due to a number of factors including the effect of "rolling" of forward contracts.

Intended Retail Investor

The unfavourable scenario for where you exit after the recommended holding period occurred to the WisdomTree Short AUD Long EUR between 23/03/2020 and 10/03/2021.

The moderate scenario for where you exit after the recommended holding period occurred to the WisdomTree Short AUD Long EUR between 26/10/2021 and 13/10/2022.

The favourable scenario for where you exit after the recommended holding period occurred to the WisdomTree Short AUD Long EUR between 25/08/2022 and 14/08/2023.

Where the period of time between the dates is less than the recommended holding period the performance has been extrapolated by linear transformation to the recommended holding period.

What happens if WisdomTree Foreign Exchange Limited is unable to pay out?

What are the costs?
