### What is this product?

#### Type

Jersey law governed, uncertificated, registered, collateralised debt security.

#### Objectives

WisdomTree Short EUR Long GBP is a fully collateralised, UCITS eligible Exchange Traded Product (ETP) designed to provide investors with an exposure to EUR relative to GBP. The ETP tracks the MSFXSM Short Euro/GBP Total Return Index (MSCEGES), providing a total return comprised of the daily performance of FX forward contracts being Short EUR relative to GBP, plus the interest revenue adjusted to reflect fees and costs associated with the product. For example, if EUR rises by 1% relative to GBP over a day, then the ETP will fall by 1%, excluding fees. However if EUR falls by 1% relative to GBP over a day, then the ETP will rise by 1%, excluding fees.

You may trade this product on various stock exchanges at your own discretion. Price changes in the forward contracts referenced in the Benchmark will not necessarily result in correlated changes in the level of the Benchmark or of the Product. This may be due to a number of factors including the effect of "rolling" of forward contracts.

#### Intended Retail Investor

This product is intended for basic retail investors who: (i) can bear loss of capital, are not seeking to preserve capital and who are not looking for capital guarantee; (ii) have specific knowledge or experience of investing in similar products and in financial markets; and (iii) seek a product offering exposure to the performance of the underlying asset(s) and have an investment horizon in line with the recommended holding period stated below.

The unfavourable scenario for where you exit after the recommended holding period occurred to the WisdomTree Short EUR Long GBP between 16/11/2015 and 02/11/2016. The moderate scenario for where you exit after the recommended holding period occurred to the WisdomTree Short EUR Long GBP between 09/11/2017 and 29/10/2018. The favourable scenario for where you exit after the recommended holding period occurred to the WisdomTree Short EUR Long GBP between 10/11/2023 and 29/10/2024. Where the period of time between the dates is less than the recommended holding period the performance has been extrapolated by linear transformation to the recommended holding period.

### What happens if WisdomTree Foreign Exchange Limited is unable to pay out?

### What are the costs?
