Objectives

WisdomTree Long GBP Short EUR is a fully collateralised, UCITS eligible Exchange Traded Product (ETP) designed to provide investors with an exposure to GBP relative to EUR. The ETP tracks the MSFXSM Long British Pound/Euro Total Return Index (MSCEEGL), providing a total return comprised of the daily performance of FX forward contracts being Long GBP relative to EUR, plus the interest revenue adjusted to reflect fees and costs associated with the product. For example, if GBP rises by 1% relative to EUR over a day, then the ETP will rise by 1%, excluding fees. However if GBP falls by 1% relative to EUR over a day, then the ETP will fall by 1%, excluding fees. You may trade this product on various stock exchanges at your own discretion. Price changes in the forward contracts referenced in the Benchmark will not necessarily

What are the risks and what could I get in return?
