What is this product?

Type

Jersey law governed, uncertificated, registered, collateralised debt security.

Objectives

WisdomTree Long GBP Short USD 3x Daily is a fully collateralised, UCITS eligible Exchange Traded Product (ETP) designed to provide investors with a leveraged exposure to GBP relative to USD. The ETP tracks the MSFXSM Triple Long British Pound Total Return Index (MSCEGBUL), providing a total return comprised of 3 times the daily performance of FX forward contracts being Long GBP relative to USD, plus the interest revenue adjusted to reflect fees and costs associated with the product. For example, if GBP rises by 1% relative to USD over a day, then the ETP will rise by 3%, excluding fees. However if GBP falls by 1% relative to USD over a day, then the ETP will fall by 3%, excluding fees.

You may trade this product on various stock exchanges at your own discretion. Price changes in the forward contracts referenced in the Benchmark will not necessarily result in correlated changes in the level of the Benchmark or of the Product. This may be due to a number of factors including the effect of "rolling" of forward contracts.

For periods of longer than one day, the return of the product is not the same as the return of the Index multiplied by a factor of 3 (the "Leverage Factor"). This is because the Leverage Factor is reset on a daily basis (i.e. the Leverage Factor is applied to the performance of the Index on each day). The daily reset has a "compounding effect" which means that, the more volatile the performance of the Index, the more the performance of the product will deviate from the performance of the Index (multiplied by the Leverage Factor) over a given period of time.

The risk indicator assumes you keep the product for 1 day. The actual risk can be significantly higher if you cash in at an early or later stage and you may get back less.
