What is this product?

Type

Jersey law governed, uncertificated, registered, collateralised debt security.

Objectives

WisdomTree Short JPY Long EUR 3x Daily is a fully collateralised, UCITS eligible Exchange Traded Product (ETP) designed to provide investors with a leveraged short exposure to JPY relative to EUR. The ETP tracks the MSFXSM Triple Short Japanese Yen/Euro Total Return Index (MSCEEJUS), providing a total return comprised of 3 times the daily performance of FX forward contracts being Short JPY relative to EUR, plus the interest revenue adjusted to reflect fees and costs associated with the product. For example, if JPY rises by 1% relative to EUR over a day, then the ETP will fall by 3%, excluding fees. However if JPY falls by 1% relative to EUR over a day, then the ETP will rise by 3%, excluding fees.

You may trade this product on various stock exchanges at your own discretion. Price changes in the forward contracts referenced in the Benchmark will not necessarily result in correlated changes in the level of the Benchmark or of the Product. This may be due to a number of factors including the effect of "rolling" of forward contracts.

For periods of longer than one day, the return of the product is not the same as the return of the Index multiplied by a factor of -3 (the "Leverage Factor"). This is because the Leverage Factor is reset on a daily basis (i.e. the Leverage Factor is applied to the performance of the Index on each day). The daily reset has a "compounding effect" which means that, the more volatile the performance of the Index, the more the performance of the product will deviate from the performance of the Index (multiplied by the Leverage factor) over a given period of time.

Intended Retail Investor

This product is intended for informed retail investors who: (i) can bear loss of capital, are not seeking to preserve capital and who are not looking for capital guarantee; (ii) have specific knowledge or experience of investing in similar products and in financial markets; and (iii) seek a product offering exposure to the performance of the underlying asset(s) and have an investment horizon in line with the recommended holding period stated below.

Term

This product does not have a fixed term. The term will depend on how long you choose to hold the product. The Issuer is entitled to terminate this product unilaterally.

What are the risks and what could I get in return?

The risk indicator assumes you keep the product for 1 day. **The actual risk can be significantly higher if you cash in at an early or later stage and you may get back less.**

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 7 out of 7, which is the highest risk class.

This rates the potential losses from future performance at a very high level.

What could affect my return positively?

+ An increase in the level of the MSFXSM Triple Short Japanese Yen/Euro Index (TR).

What could affect my return negatively?

+ A decrease in the level of the MSFXSM Triple Short Japanese Yen/Euro Index (TR).

What are the costs?
