What is this product?

Type

Objectives

WisdomTree Short JPY Long EUR is a fully collateralised, UCITS eligible Exchange Traded Product (ETP) designed to provide investors with an exposure to JPY relative to EUR. The ETP tracks the MSFXSM Short Japanese Yen/Euro Total Return Index (MSCEEJS), providing a total return comprised of the daily performance of FX forward contracts being Short JPY relative to EUR, plus the interest revenue adjusted to reflect fees and costs associated with the product. For example, if JPY rises by 1% relative to EUR over a day, then the ETP will fall by 1%, excluding fees.

You may trade this product on various stock exchanges at your own discretion. Price changes in the forward contracts referenced in the Benchmark will not necessarily.

The moderate scenario for where you exit after the recommended holding period occurred to the WisdomTree Short JPY Long EUR between 29/09/2020 and 16/09/2021. The favourable scenario for where you exit after the recommended holding period occurred to the WisdomTree Short JPY Long EUR between 15/03/2023 and 01/03/2024. Where the period of time between the dates is less than the recommended holding period the performance has been extrapolated by linear transformation to the recommended holding period.
