What is this product?

Type

Jersey law governed, uncertificated, registered, collateralised debt security.

Objectives

WisdomTree Short JPY Long EUR is a fully collateralised, UCITS eligible Exchange Traded Product (ETP) designed to provide investors with an exposure to JPY relative to EUR. The ETP tracks the MSFXSM Short Japanese Yen/Euro Total Return Index (MSCEEJS), providing a total return comprised of the daily performance of FX forward contracts being Short JPY relative to EUR, plus the interest revenue adjusted to reflect fees and costs associated with the product. For example, if JPY rises by 1% relative to EUR over a day, then the ETP will fall by 1%, excluding fees. However if JPY falls by 1% relative to EUR over a day, then the ETP will rise by 1%, excluding fees.

You may trade this product on various stock exchanges at your own discretion. Price changes in the forward contracts referenced in the Benchmark will not necessarily result in correlated changes in the level of the Benchmark or of the Product. This may be due to a number of factors including the effect of "rolling" of forward contracts.

Intended Retail Investor

This product is intended for basic retail investors who: (i) can bear loss of capital, are not seeking to preserve capital and who are not looking for capital guarantee; (ii) have specific knowledge or experience of investing in similar products and in financial markets; and (iii) seek a product offering exposure to the performance of the underlying asset(s) and have an investment horizon in line with the recommended holding period stated below.

Term

The stress scenario shows what you might get back in extreme market circumstance.

The unfavourable scenario for where you exit after the recommended holding period occurred to the WisdomTree Short JPY Long EUR between 14/09/2018 and 03/09/2019.

The moderate scenario for where you exit after the recommended holding period occurred to the WisdomTree Short JPY Long EUR between 23/10/2020 and 12/10/2021.

The favourable scenario for where you exit after the recommended holding period occurred to the WisdomTree Short JPY Long EUR between 15/03/2023 and 01/03/2024.

Where the period of time between the dates is less than the recommended holding period the performance has been extrapolated by linear transformation to the recommended holding period.

What happens if WisdomTree Foreign Exchange Limited is unable to pay out?

What are the costs?
