Objectives

WisdomTree Corn - EUR Daily Hedged is a fully collateralised, UCITS eligible Exchange Traded Commodity (ETC) designed to provide investors with a total return exposure to Corn futures contracts currency hedged in EUR. The ETC aims to replicate the Bloomberg Corn Sub Euro Hedged Daily Total Return Index (BUCNDET) by tracking the Bloomberg Corn Sub Euro Hedged Daily Excess Return Index and providing the interest revenue adjusted to reflect fees and costs associated with the product. For example, if the Bloomberg Corn Sub Euro Hedged Daily Total Return Index rises by 1% over a day, then the ETC will rise by 1%, excluding fees. However if the Bloomberg Corn Sub Euro Hedged Daily Total Return Index rises by 1% over a day, then the ETC will rise by 1%, excluding fees.

The moderate scenario for where you exit after the recommended holding period occurred to the WisdomTree Corn - EUR Daily Hedged between 08/02/2018 and 28/01/2019. The favourable scenario for where you exit after the recommended holding period occurred to the WisdomTree Corn - EUR Daily Hedged between 20/05/2020 and 07/05/2021.
