Objectives

WisdomTree Aluminium - EUR Daily Hedged is a fully collateralised, UCITS eligible Exchange Traded Commodity (ETC) designed to provide investors with a total return exposure to Aluminium futures contracts currency hedged in EUR. The ETC aims to replicate the Bloomberg Aluminum Sub Euro Hedged Daily Total Return Index (BUALDET) by tracking the Bloomberg Aluminum Sub Euro Hedged Daily Excess Return Index and providing the interest revenue adjusted to reflect fees and costs associated with the product. For example, if the Bloomberg Aluminum Sub Euro Hedged Daily Total Return Index falls by 1% over a day, then the ETC will rise by 1%, excluding fees. However if the Bloomberg Aluminum Sub Euro Hedged Daily Total Return Index falls by 1% over a day, then the ETC will fall by 1%, excluding fees.

What are the risks and what could I get in return?
