# What is this product?

### **Objectives**

WisdomTree Nickel - EUR Daily Hedged is a fully collateralised, UCITS eligible Exchange Traded Commodity (ETC) designed to provide investors with a total return exposure to Nickel futures contracts currency hedged in EUR. The ETC aims to replicate the Bloomberg Nickel Sub Euro Hedged Daily Total Return Index (BUNIDET) by tracking the Bloomberg Nickel Sub Euro Hedged Daily Euro Hedged Daily Excess Return Index and providing the interest revenue adjusted to reflect fees and costs associated with the product. For example, if the Bloomberg Nickel Sub Euro Hedged Daily Total Return Index for Providing the Sub Euro Hedged Daily Total Return Index for a day, then the ETC will rise by 1%, excluding fees. However if the Bloomberg Nickel Sub Euro Hedged Daily Total Return Index for a day, then the ETC will fall by 1%, excluding fees.
