What is this product?

Type

Jersey law governed, uncertificated, registered, collateralised debt security.

Objectives

WisdomTree Brent Crude Oil - EUR Daily Hedged is a fully collateralised, UCITS eligible Exchange Traded Commodity (ETC) designed to provide investors with a total return exposure to Brent Crude Oil futures contracts currency hedged in EUR. The ETC aims to replicate the Bloomberg Brent Crude Oil Multi-Tenor EUR Daily-Hedged Total Return Index (BCOMTTRE) by tracking the Bloomberg Brent Crude Oil Multi-Tenor EUR Daily-Hedged Excess Return Index and providing the interest revenue adjusted to reflect fees and costs associated with the product. For example, if the Bloomberg Brent Crude Oil Multi-Tenor EUR Daily-Hedged Total Return Index rises by 1% over a day, then the ETC will rise by 1%, excluding fees. However if the Bloomberg Brent Crude Oil Multi-Tenor EUR Daily-Hedged Total Return Index falls by 1% over a day, then the ETC will fall by 1%, excluding fees.

You may trade this product on various stock exchanges at your own discretion. Price changes in the futures contracts referenced in the Benchmark will not necessarily result in correlated changes in the level of the Benchmark or of the Product. This may be due to a number of factors including the effect of "rolling" of futures contracts.

Intended Retail Investor

This product is intended for basic retail investors who: (i) can bear loss of capital, are not seeking to preserve capital and who are not looking for capital guarantee; (ii) have specific knowledge or experience of investing in similar products and in financial markets; and (iii) seek a product offering exposure to the performance of the underlying asset(s) and have an investment horizon in line with the recommended holding period stated below.

Term

This product does not have a fixed term. The term will depend on how long you choose to hold the product. The Issuer is entitled to terminate this product unilaterally.

What are the risks and what could I get in return?



The risk indicator assumes you keep the product for 1 year. **The actual risk can be significantly higher if you cash in at an early or later stage and you may get back less.**

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 6 out of 7, which is the second-highest risk class.

This rates the potential losses from future performance at a high level.

Be aware of currency risk. If the trading currency is different to the base currency, you will receive payments in a different currency, so the final return you will get will depend on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

The stress scenario shows what you might get back in extreme market circumstance.

The unfavourable scenario for where you exit after the recommended holding period occurred to the WisdomTree Brent Crude Oil - EUR Daily Hedged between 10/05/2019 and 28/04/2020. The moderate scenario for where you exit after the recommended holding period occurred to the WisdomTree Brent Crude Oil - EUR Daily Hedged between 24/11/2022 and 13/11/2023. The favourable scenario for where you exit after the recommended holding period occurred to the WisdomTree Brent Crude Oil - EUR Daily Hedged between 28/04/2020 and 15/04/2021. Where the period of time between the dates is less than the recommended holding period the performance has been extrapolated by linear transformation to the recommended holding period.

What happens if WisdomTree Hedged Commodity Securities Limited is unable to pay out?

What are the costs?
