#### **Objectives**

WisdomTree Brent Crude Oil - GBP Daily Hedged is a fully collateralised, UCITS eligible Exchange Traded Commodity (ETC) designed to provide investors with a total return exposure to Brent Crude Oil futures contracts currency hedged in GBP. The ETC aims to replicate the Bloomberg Brent Crude Oil Multi-Tenor GBP Daily-Hedged Total Return Index (BCOMTTRP) by tracking the Bloomberg Brent Crude Oil Multi-Tenor GBP Daily-Hedged Excess Return Index and providing the interest revenue adjusted to reflect fees and costs associated with the product. For example, if the Bloomberg Brent Crude Oil Multi-Tenor GBP Daily-Hedged Total Return Index is by 1%, excluding fees. However if the Bloomberg Brent Crude Oil Multi-Tenor GBP Daily-Hedged Total Return Index falls by 1% over a day, then the ETC will fall by 1%, excluding fees.

What are the risks and what could I get in return?



The risk indicator assumes you keep the product for 1 year. The actual risk can be significantly higher if you cash in at an early or later stage and you may get back less.
