### What is this product?

#### Type

Jersey law governed, uncertificated, registered, collateralised debt security.

#### Objectives

WisdomTree Broad Commodities - EUR Daily Hedged is a fully collateralised, UCITS eligible Exchange Traded Commodity (ETC) designed to provide investors with a total return exposure to a basket of Broad Commodities futures contracts. The ETC aims to replicate the Bloomberg Commodity Euro Hedged Daily Total Return Index (BCOMDET) by tracking the Bloomberg Commodity Euro Hedged Daily Excess Return Index and providing the interest revenue adjusted to reflect fees and costs associated with the product. For example, if the Bloomberg Commodity Euro Hedged Daily Total Return Index rises by 1% over a day, then the ETC will rise by 1%, excluding fees. However if the Bloomberg Commodity Euro Hedged Daily Total Return Index falls by 1% over a day, then the ETC will fall by 1%, excluding fees. You may trade this product on various stock exchanges at your own discretion. Price changes in the futures contracts referenced in the Benchmark will not necessarily result in correlated changes in the level of the Benchmark or of the Product. This may be due to a number of factors including the effect of "rolling" of futures contracts.

#### Intended Retail Investor

This product is intended for basic retail investors who: (i) can bear loss of capital, are not seeking to preserve capital and who are not looking for capital guarantee; (ii) have specific knowledge or experience of investing in similar products and in financial markets; and (iii) seek a product offering exposure to the performance of the underlying asset(s) and have an investment horizon in line with the recommended holding period stated below.

#### Term

The unfavourable scenario for where you exit after the recommended holding period occurred to the WisdomTree Broad Commodities - EUR Daily Hedged between 20/05/2015 and 18/03/2020. The moderate scenario for where you exit after the recommended holding period occurred to the WisdomTree Broad Commodities - EUR Daily Hedged between 15/10/2018 and 14/08/2023. The favourable scenario for where you exit after the recommended holding period occurred to the WisdomTree Broad Commodities - EUR Daily Hedged between 22/06/2017 and 21/04/2022. Where the period of time between the dates is less than the recommended holding period the performance has been extrapolated by linear transformation to the recommended holding period.

### What happens if WisdomTree Hedged Commodity Securities Limited is unable to pay out?

### What are the costs?
