What is this product?

Type

Jersey law governed, uncertificated, registered, collateralised debt security.

Objectives

WisdomTree Precious Metals - EUR Daily Hedged is a fully collateralised, UCITS eligible Exchange Traded Commodity (ETC) designed to provide investors with a total return exposure to a basket of Precious Metals futures contracts. The ETC aims to replicate the Bloomberg Precious Metals Sub Euro Hedged Daily Total Return Index (BUPRDET) by tracking the Bloomberg Precious Metals Sub Euro Hedged Daily Excess Return Index and providing the interest revenue adjusted to reflect fees and costs associated with the product. For example, if the Bloomberg Precious Metals Sub Euro Hedged Daily Total Return Index rises by 1% over a day, then the ETC will rise by 1%, excluding fees. However if the Bloomberg Precious Metals Sub Euro Hedged Daily Total Return Index falls by 1% over a day, then the ETC will fall by 1%, excluding fees.

You may trade this product on various stock exchanges at your own discretion. Price changes in the futures contracts referenced in the Benchmark will not necessarily result in correlated changes in the level of the Benchmark or of the Product. The unfavourable scenario for where you exit after the recommended holding period occurred to the WisdomTree Precious Metals - EUR Daily Hedged between 18/05/2015 and 16/03/2020. The moderate scenario for where you exit after the recommended holding period occurred to the WisdomTree Precious Metals - EUR Daily Hedged between 26/06/2017 and 25/04/2022. The favourable scenario for where you exit after the recommended holding period occurred to the WisdomTree Precious Metals - EUR Daily Hedged between 24/12/2019 and 22/10/2024. Where the period of time between the dates is less than the recommended holding period the performance has been extrapolated by linear transformation to the recommended holding period.
