What is this product?

Type

Jersey law governed, uncertificated, registered, collateralised debt security.

Objectives

WisdomTree Aluminium - EUR Daily Hedged is a fully collateralised, UCITS eligible Exchange Traded Commodity (ETC) designed to provide investors with a total return exposure to Aluminium futures contracts currency hedged in EUR. The ETC aims to replicate the Bloomberg Aluminum Sub Euro Hedged Daily Total Return Index (BUALDET) by tracking the Bloomberg Aluminum Sub Euro Hedged Daily Excess Return Index and providing the interest revenue adjusted to reflect fees and costs associated with the product. For example, if the Bloomberg Aluminum Sub Euro Hedged Daily Total Return Index rises by 1% over a day, then the ETC will rise by 1%, excluding fees. However if the Bloomberg Aluminum Sub Euro Hedged Daily Total Return Index falls by 1% over a day, then the ETC will fall by 1%, excluding fees.

You may trade this product on various stock exchanges at your own discretion. Price changes in the futures contracts referenced in the Benchmark will not necessarily result in correlated changes in the level of the Benchmark or of the Product.
