What is this product?

Type

Jersey law governed, uncertificated, registered, collateralised debt security.

Objectives

WisdomTree WTI Crude Oil - EUR Daily Hedged is a fully collateralised, UCITS eligible Exchange Traded Commodity (ETC) designed to provide investors with a total return exposure to WTI Crude Oil futures contracts currency hedged in EUR. The ETC aims to replicate the Bloomberg WTI Crude Oil Sub Euro Hedged Daily Total Return Index (BUCLDET) by tracking the Bloomberg WTI Crude Oil Sub Euro Hedged Daily Excess Return Index and providing the interest revenue adjusted to reflect fees and costs associated with the product. For example, if the Bloomberg WTI Crude Oil Sub Euro Hedged Daily Total Return Index rises by 1% over a day, then the ETC will rise by 1%, excluding fees. However if the Bloomberg WTI Crude Oil Sub Euro Hedged Daily Total Return Index falls by 1% over a day, then the ETC will fall by 1%, excluding fees. You may trade this product on various stock exchanges at your own discretion. Price changes in the futures contracts referenced in the Benchmark will not necessarily result in correlated changes in the level of the Benchmark or of the Product. This may be due to a number of factors including the effect of "rolling" of futures contracts.

Intended Retail Investor

The unfavourable scenario for where you exit after the recommended holding period occurred to the WisdomTree WTI Crude Oil - EUR Daily Hedged between 10/05/2019 and 28/04/2020. The moderate scenario for where you exit after the recommended holding period occurred to the WisdomTree WTI Crude Oil - EUR Daily Hedged between 26/04/2018 and 15/04/2019. The favourable scenario for where you exit after the recommended holding period occurred to the WisdomTree WTI Crude Oil - EUR Daily Hedged between 28/04/2020 and 15/04/2021. Where period of time between the dates is less than the recommended holding period the performance has been extrapolated by linear transformation to the recommended holding period.

What happens if WisdomTree Hedged Commodity Securities Limited is unable to pay out?

What are the costs?
