# What is this product?

#### **Objectives**

WisdomTree WTI Crude Oil - EUR Daily Hedged is a fully collateralised, UCITS eligible Exchange Traded Commodity (ETC) designed to provide investors with a total return exposure to WTI Crude Oil futures contracts currency hedged in EUR. The ETC aims to replicate the Bloomberg WTI Crude Oil Sub Euro Hedged Daily Total Return Index (BUCLDET) by tracking the Bloomberg WTI Crude Oil Sub Euro Hedged Daily Excess Return Index and providing the interest revenue adjusted to reflect fees and costs associated with the product. For example, if the Bloomberg WTI Crude Oil Sub Euro Hedged Daily Total Return Index falls by 1% over a day, then the ETC will rise by 1%, excluding fees. However if the Bloomberg WTI Crude Oil Sub Euro Hedged Daily Total Return Index falls by 1% over a day, then the ETC will rise by 1%, You may trade this product on various stock exchanges at your own discretion.
