What is this product?

Type

Jersey law governed, uncertificated, registered, collateralised debt security.

Objectives

WisdomTree Wheat - EUR Daily Hedged is a fully collateralised, UCITS eligible Exchange Traded Commodity (ETC) designed to provide investors with a total return exposure to Wheat futures contracts currency hedged in EUR. The ETC aims to replicate the Bloomberg Wheat Sub Euro Hedged Daily Total Return Index (BUWHDET) by tracking the Bloomberg Wheat Sub Euro Hedged Daily Excess Return Index and providing the interest revenue adjusted to reflect fees and costs associated with the product. For example, if the Bloomberg Wheat Sub Euro Hedged Daily Total Return Index rises by 1% over a day, then the ETC will rise by 1%, excluding fees. However if the Bloomberg Wheat Sub Euro Hedged Daily Total Return Index falls by 1% over a day, then the ETC will fall by 1%, excluding fees. You may trade this product on various stock exchanges at your own discretion. Price changes in the futures contracts referenced in the Benchmark will not necessarily result in correlated changes in the level of the Benchmark or of the Product. This may be due to a number of factors including the effect of "rolling" of futures contracts.

Intended Retail Investor

The unfavourable scenario for where you exit after the recommended holding period occurred to the WisdomTree Wheat - EUR Daily Hedged between 17/05/2022 and 04/05/2023. The moderate scenario for where you exit after the recommended holding period occurred to the WisdomTree Wheat - EUR Daily Hedged between 26/09/2017 and 13/09/2018. The favourable scenario for where you exit after the recommended holding period occurred to the WisdomTree Wheat - EUR Daily Hedged between 18/03/2021 and 07/03/2022. Where the period of time between the dates is less than the recommended holding period the performance has been extrapolated by linear transformation to the recommended holding period.

What happens if WisdomTree Hedged Commodity Securities Limited is unable to pay out?

What are the costs?
