What is this product?

Type

Jersey law governed, uncertificated, registered, collateralised debt security.

Objectives

WisdomTree Physical Silver - GBP Daily Hedged is a UCITS Eligible Exchange Traded Commodity (ETC) designed to offer security holders a simple, cost-efficient and secure way to access Physical Silver while mitigating currency risk. The product enables investors to gain exposure to the Physical Silver spot price, less applicable fees, with a daily hedge against movements in the GBP/USD exchange rate. WisdomTree Physical Silver - GBP Daily Hedged is backed by allocated Physical Silver held by HSBC Bank plc (the custodian). Only metal that conforms with the London Bullion Market Association's (LBMA) rules for Good Delivery can be accepted by the custodian. Each physical bar is segregated, individually identified and allocated.

Each individual WisdomTree Physical Silver - GBP Daily Hedged security has an effective entitlement to silver. That entitlement is (i) adjusted by the currency hedge (upwards or downwards depending on currency movements) and (ii) reduced by the management fee and hedging costs. As a result, there is no cash component and the security maintains a direct relation to the value of the underlying precious metal in the relevant currency.

The currency hedge is provided through arrangements with an FX counterparty (Morgan Stanley & Co. International plc) that provides, on an unfunded basis, exposure to the Morgan Stanley GBP Daily Hedged Physical Silver Index (MSCESLBP) which tracks movements in the GBP/USD exchange rate in silver terms. The Index incorporates a fixed exchange rate spread to reflect the cost of implementing the currency hedge; this spread is embedded in the Index level as part of its calculation methodology.

Authorised participants create and redeem the securities by delivering or receiving silver that conforms to LBMA Good Delivery standards. The securities are traded on exchange at a price that is based on the spot price of silver multiplied by the applicable metal entitlement and adjusted by the relevant FX rate.

You may trade this product on various stock exchanges at your own discretion.

Intended Retail Investor

Term

What are the costs?
