Objectives

WisdomTree Physical Gold is a UCITS Eligible Exchange Traded Commodity (ETC) designed to offer security holders a simple, cost-efficient and secure way to access Physical Gold by providing a return equivalent to the movements in the Physical Gold spot price less the applicable management fee. WisdomTree Physical Gold is backed by physical, allocated Physical Gold held by HSBC Bank plc (the custodian). Only metal that conforms with the London Bullion Market Association's (LBMA) rules for Good Delivery can be accepted by the custodian. Each physical Gold fields by 1% over a day, then the ETC will rise by 1%, excluding fees. However if Physical Gold fields by 1% over a day, then the ETC will fall by 1%, excluding fees. You may trade this product on various stock exchanges at your own discretion.

Term

This product does not have a fixed term. The term will depend on how long you choose to hold the product. The Issuer is entitled to terminate this product unilaterally.



What are the risks and what could I get in return?



The risk indicator assumes you keep the product for 5 years. The actual risk can be significantly higher if you cash in at an early or later stage and you may get back less.

The unfavourable scenario for where you exit after the recommended holding period occurred to the WisdomTree Physical Gold between 18/05/2015 and 16/03/2020. The favourable scenario for where you exit after the recommended holding period occurred to the WisdomTree Physical Gold between 23/12/2019 and 21/10/2024.
