The ETP also generates a staking yield based on the portion of the assets staked which helps to participate and secure the Ethereum network. The ETP provides for easy investor access, tradability, transparency and institutional custody solutions within a robust physically backed structure. You may trade this product on various stock exchanges at your own discretion.

What are the costs?
