Objectives

WisdomTree Physical Ethereum is a physically backed Exchange Traded Product (ETP) designed to offer shareholders a simple, secure and cost-efficient way to gain exposure to the price of Ethereum. The ETP also generates a staking yield based on the portion of the assets staked which helps to participate and secure the Ethereum network. The ETP provides for easy investor access, tradability, transparency and institutional custody solutions within a robust physically backed structure.

You may trade this product on various stock exchanges at your own discretion.

Intended Retail Investor

The risk indicator assumes you keep the product for 5 years. **The actual risk can be significantly higher if you cash in at an early or later stage and you may get back less.**

The unfavourable scenario for where you exit after the recommended holding period occurred to the CME CF Ether-Dollar Reference Rate between 10/11/2021 and 17/01/2024. The moderate scenario for where you exit after the recommended holding period occurred to the CME CF Ether-Dollar Reference Rate between 22/11/2018 and 21/09/2023. The favourable scenario for where you exit after the recommended holding period occurred to the CME CF Ether-Dollar Reference Rate between 13/07/2016 and 12/05/2021. Where the period of time between the dates is less than the recommended holding period the performance has been extrapolated by linear transformation to the recommended holding period.

What are the costs?
