Objectives

WisdomTree Physical Lido Staked Ether is a physically backed Exchange Traded Product (ETP) designed to offer shareholders a simple, secure and cost-efficient way to gain exposure to the price of Lido Staked Ether. The ETP also generates a staking yield via stETH's daily rebase mechanism which participates in the incentives that help secure the Ethereum network. The ETP provides for easy investor access, tradability, transparency and institutional custody solutions within a robust physically backed structure. You may trade this product on various stock exchanges at your own discretion.

Intended Retail Investor

This product is intended for informed retail investors who: (i) can bear loss of capital, are not seeking to preserve capital and who are not looking for capital guarantee; (ii) have specific knowledge or experience of investing in similar products and in financial markets; and (iii) seek a product offering exposure to the performance of the underlying asset(s) and have an investment horizon in line with the recommended holding period stated below.

Term

This product does not have a fixed term. The term will depend on how long you choose to hold the product. The Issuer is entitled to terminate this product unilaterally.

What are the risks and what could I get in return?

What are the costs?
