What is this product?

Type

English law governed, certificated, registered, collateralised debt security.

Objectives

WisdomTree Energy Enhanced - EUR Daily Hedged is a fully collateralised, UCITS eligible Exchange Traded Commodity (ETC) designed to provide investors with a total return exposure to a basket of Energy currency hedged in Euro futures contracts. The ETC provides a total return comprised of the daily performance of the Optimized Roll Energy EUR-Hedged Total Return Index (EBCIENEU), adjusted to reflect fees and costs associated with the product. For example, if the Optimized Roll Energy EUR-Hedged Total Return Index rises by 1% over a day, then the ETC will rise by 1%, excluding fees. However if the Optimized Roll Energy EUR-Hedged Total Return Index falls by 1% over a day, then the ETC will fall by 1%, excluding fees.

You may trade this product on various stock exchanges at your own discretion. Price changes in the futures contracts referenced in the Benchmark will not necessarily result in correlated changes in the level of the Benchmark or of the Product. This may be due to a number of factors including the effect of "rolling" of futures contracts.

Intended Retail Investor

The unfavourable scenario for where you exit after the recommended holding period occurred to the Optimised Roll Energy EUR-Hedged Total Return Index between 16/06/2014 and 09/05/2017. The moderate scenario for where you exit after the recommended holding period occurred to the Optimised Roll Energy EUR-Hedged Total Return Index between 25/01/2019 and 20/12/2021. The favourable scenario for where you exit after the recommended holding period occurred to the Optimised Roll Energy EUR-Hedged Total Return Index between 18/07/2019 and 10/06/2022. Where the period of time between the dates is less than the recommended holding period the performance has been extrapolated by linear transformation to the recommended holding period.

What are the costs?
