Objectives

WisdomTree FTSE 100 2x Daily Short is a fully collateralised, UCITS eligible Exchange Traded Product (ETP) designed to provide investors with a leveraged short exposure to the FTSE 100. The ETP tracks the FTSE 100 Daily Super Short Strategy RT Gross TR Index (UKXI2X), providing a total return comprised of -2 times the daily performance of the FTSE 100 Declared Dividend Total Return Index, adjusted to reflect fees as well as the costs and revenues inherent to shorting stocks. For example, if the FTSE 100 Declared Dividend Total Return Index, then the ETP will fall by 2%, excluding fees. However if the FTSE 100 Declared Dividend Total Return Index falls by 1% over a day, then the ETP will fall by 2%, excluding fees.

You may trade this product on various stock exchanges at your own discretion. Price changes in the futures contracts referenced in the Benchmark will not necessarily result in correlated changes in the level of the Benchmark or of the Product. This may be due to a number of factors including the effect of "rolling" of futures contracts.

For periods of longer than one day, the return of the product is not the same as the return of the Index multiplied by a factor of -2 (the "Leverage Factor"). Term

The risk indicator assumes you keep the product for 1 day. The actual risk can be significantly higher if you cash in at an early or later stage and you may get back less.

We have classified this product as 7 out of 7, which is the highest risk class.

This rates the potential losses from future performance at a very high level.
