# What is this product?

## **Objectives**

WisdomTree Bloomberg WTI Crude Oil is a fully collateralised, UCITS eligible Exchange Traded Commodity (ETC) designed to provide investors with a total return exposure to WTI Crude Oil futures contracts. The ETC provides a total return comprised of the daily performance of the Bloomberg WTI Crude Oil Sub Index (BCOMCL), plus the interest revenue adjusted to reflect fees and costs associated with the product. For example, if the Bloomberg WTI Crude Oil Sub Index rises by 1% over a day, then the ETC will rise by 1%, excluding fees. However if the Bloomberg WTI Crude Oil Sub Index falls by 1% over a day, then the ETC will fall by 1%, excluding fees.

You may trade this product on various stock exchanges at your own discretion. Price changes in the futures contracts referenced in the Benchmark will not necessarily result in correlated changes in the level of the Benchmark or of the Product. This may be due to a number of factors including the effect of "rolling" of futures contracts.

#### Term

This product does not have a fixed term. The term will depend on how long you choose to hold the product however, the final maturity date is 30 November 2062. The Issuer is entitled to terminate this product unilaterally.







The risk indicator assumes you keep the product for 1 year. The actual risk can be significantly higher if you cash in at an early or later stage and you may get back less.

# What are the costs?
