What is this product?

Type

English law governed, certificated, registered, collateralised debt security.

Objectives

WisdomTree US Treasuries 10Y 5x Daily Short is a UCITS eligible and fully collateralised Exchange Traded Product (ETP) designed to provide investors with a leveraged short exposure to US 10Yr Treasuries futures contracts. The ETP provides a total return comprised of -5 times the daily performance of the US Treasury Note 10y Rolling Future Index (BNSXFTYU), plus the interest revenue adjusted to reflect fees and costs associated with the product. For example, if the US Treasury Note 10y Rolling Future Index rises by 1% over a day, then the ETP will fall by 5%, excluding fees. However if the US Treasury Note 10y Rolling Future Index falls by 1% over a day, then the ETP will rise by 5%, excluding fees.

You may trade this product on various stock exchanges at your own discretion. Price changes in the futures contracts referenced in the Benchmark will not necessarily result in correlated changes in the level of the Benchmark or of the Product. This may be due to a number of factors including the effect of "rolling" of futures contracts.

For periods of longer than one day, the return of the product is not the same as the return of the Index multiplied by a factor of -5 (the "Leverage Factor"). This is because the Leverage Factor is reset on a daily basis (i.e. the Leverage Factor is applied to the performance of the Index on each day). The daily reset has a "compounding effect" which means that, the more volatile the performance of the Index, the more the performance of the product will deviate from the performance of the Index (multiplied by the Leverage factor) over a given period of time.

Intended Retail Investor

This product is intended for informed retail investors who: (i) can bear loss of capital, are not seeking to preserve capital and who are not looking for capital guarantee; (ii) have specific knowledge or experience of investing in similar products and in financial markets; and (iii) seek a product offering exposure to the performance of the underlying asset(s) and have an investment horizon in line with the recommended holding period stated below.

Term

This product does not have a fixed term. The term will depend on how long you choose to hold the product however, the final maturity date is 30 November 2062. The Issuer is entitled to terminate this product unilaterally.

What are the risks and what could I get in return?

The risk indicator assumes you keep the product for 1 day. **The actual risk can be significantly higher if you cash in at an early or later stage and you may get back less.**

We have classified this product as 7 out of 7, which is the highest risk class.

This rates the potential losses from future performance at a very high level.

Factors affecting the return of the product at the end of the recommended holding period

What could affect my return positively?

+ A decrease in the level of the US Treasury Note 10Y Rolling Future Index.

What could affect my return negatively?

+ An increase in the level of the US Treasury Note 10Y Rolling Future Index.

What are the costs?
