What is this product?

Objectives

WisdomTree Energy Enhanced - EUR Daily Hedged is a fully collateralised, UCITS eligible Exchange Traded Commodity (ETC) designed to provide investors with a total return exposure to a basket of Energy currency hedged in Euro futures contracts. The ETC provides a total return comprised of the daily performance of the Optimized Roll Energy EUR-Hedged Total Return Index (EBCIENEU), adjusted to reflect fees and costs associated with the product. For example, if the Optimized Roll Energy EUR-Hedged Total Return Index rises by 1% over a day, then the ETC will rise by 1%, excluding fees. However if the Optimized Roll Energy EUR-Hedged Total Return Index falls by 1%, excluding fees.

You may trade this product on various stock exchanges at your own discretion.
