What is this product?

Type

English law governed, certificated, registered, collateralised debt security.

Objectives

WisdomTree Battery Metals is a fully collateralised, UCITS eligible Exchange Traded Commodity (ETC) designed to provide investors with a total return exposure to a basket of Battery Metals futures contracts. The ETC provides a total return comprised of the daily performance of the WisdomTree Battery Metals Commodity Index (WTBMCTR), adjusted to reflect fees and costs associated with the product. For example, if the WisdomTree Battery Metals Commodity Index rises by 1% over a day, then the ETC will rise by 1%, excluding fees. However if the WisdomTree Battery Metals Commodity Index falls by 1% over a day, then the ETC will fall by 1%, excluding fees.

You may trade this product on various stock exchanges at your own discretion. Price changes in the futures contracts referenced in the Benchmark will not necessarily result in correlated changes in the level of the Benchmark or of the Product. This may be due to a number of factors including the effect of "rolling" of futures contracts.

Intended Retail Investor

Term

This product does not have a fixed term. The term will depend on how long you choose to hold the product however, the final maturity date is 30 November 2062. The Issuer is entitled to terminate this product unilaterally.

The moderate scenario for where you exit after the recommended holding period occurred to the WisdomTree Battery Metals Commodity Index between 04/08/2020 and 28/06/2023. The favourable scenario for where you exit after the recommended holding period occurred to the WisdomTree Battery Metals Commodity Index between 12/04/2019 and 07/03/2022. Where the period of time between the dates is less than the recommended holding period the performance has been extrapolated by linear transformation to the recommended holding period.

What are the costs?
