### What is this product?

#### Type

English law governed, certificated, registered, collateralised debt security.

#### Objectives

WisdomTree EURO STOXX 50 is a fully collateralised, UCITS eligible Exchange Traded Product (ETP) designed to provide investors with a total return exposure to EURO STOXX 50. The ETP provides a total return comprised of the daily performance of the ESTX 50 EUR (Net Return) Index (SX5T), adjusted to reflect fees and costs associated with the product. For example, if the ESTX 50 EUR (Net Return) Index rises by 1% over a day, then the ETP will rise by 1%, excluding fees. However if the ESTX 50 EUR (Net Return) Index falls by 1% over a day, then the ETP will fall by 1%, excluding fees. You may trade this product on various stock exchanges at your own discretion. Price changes in the futures contracts referenced in the Benchmark will not necessarily result in correlated changes in the level of the Benchmark or of the Product. This may be due to a number of factors including the effect of "rolling" of futures contracts.

#### Intended Retail Investor

The unfavourable scenario for where you exit after the recommended holding period occurred to the ESTX 50 EUR (Net Return) between 20/05/2015 and 18/03/2020. The moderate scenario for where you exit after the recommended holding period occurred to the ESTX 50 EUR (Net Return) between 19/12/2016 and 18/10/2021. The favourable scenario for where you exit after the recommended holding period occurred to the ESTX 50 EUR (Net Return) between 14/08/2019 and 12/06/2024. Where the period of time between the dates is less than the recommended holding period the performance has been extrapolated by linear transformation to the recommended holding period.

### What are the costs?
