Objectives

WisdomTree NASDAQ 100 5x Daily Short is a UCITS eligible and fully collateralised Exchange Traded Product (ETP) designed to provide investors with a leveraged short exposure to NASDAQ 100 futures contracts. The ETP provides a total return comprised of -5 times the daily performance of the US Technology Rolling Futures ER Index (BNSXFTUS), plus the interest revenue adjusted to reflect fees and costs associated with the product. For example, if the US Technology Rolling Futures ER Index rises by 1% over a day, then the ETP will fall by 5%, excluding fees. However if the US Technology Rolling Futures ER Index fees.

You may trade this product on various stock exchanges at your own discretion. Price changes in the futures contracts referenced in the Benchmark will not necessarily result in correlated changes in the level of the Benchmark or of the Product.
